TRADE CIRCULAR

Sub: Indexation for PPP projects with reference to the variation in Wholesale Price Index (WPI)

Indexation of tariff caps in respect of reference tariff cases under the 2013 guidelines for PPP projects at Major Port Authorities shall be carried out with reference to the variation in WPI. Accordingly, an indexation factor of 0.39%, being 60% of the variation in WPI, shall be applicable for the financial year 2026-27 (i.e. from 01.04.2026 to 31.03.2027), as communicated by IPA vide letter No.IPA/P&P/WPI/2025 dated 31.03.2026 (copy enclosed).

Sub: Indexation of Tariff caps in the reference tariff cases under 2013 guidelines for PPP projects at the Major port Authorities with reference to variation in wholesale price index(WPI)

Ref: IPA letter no. IPA/P&P/WPI/2025 dt. 27/03/2026

Sir/ Madam,

In continuation to our letter dt. 27/03/2026 referred above, indexation of tariff caps for PPP operators, shore handling and stevedoring has been worked out.

The indexation factors with reference to the variation in wholesale price index occurring between January 2025 and December 2025 is as follows;

- a) Indexation factor of 0.65 % for computation of indexed ARR as per Clause 2.3 of the Tariff Policy for Major Port Authorities, 2021 for the year 2026-27
- b) Automatic annual indexation of SOR as per clause 2.8.1 of the Tariff Policy for Major Port Authorities, 2021 considering 60% of variation in WPI occurring between 1st January 2025 and 31st December 2025 is 0.39 %

Major Port Authorities are requested to communicate the indexation factors to PPP operators, stevedores and shore handling operators accordingly.

A copy of the calculation sheet of indexation factors is enclosed herewith (**Annexure I**)
